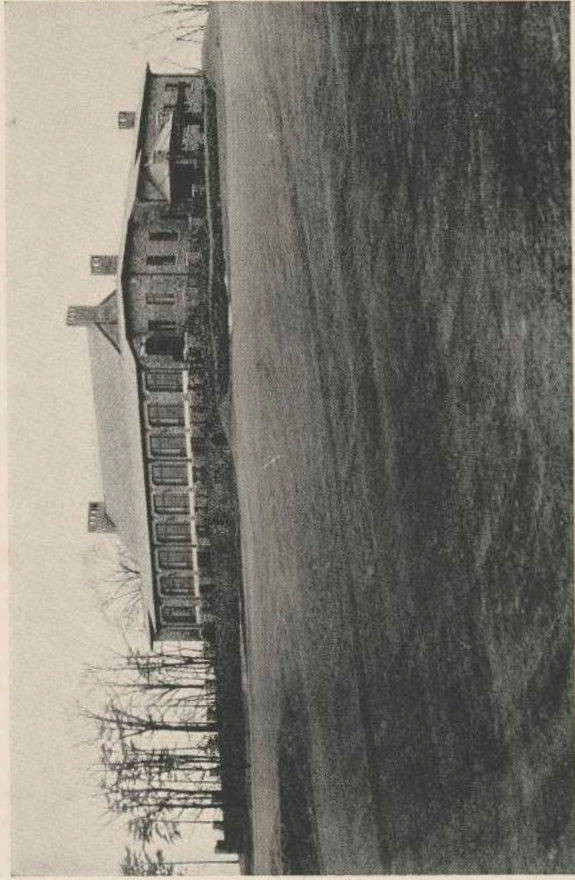

HISTORY OF THE CLUB

YORK COUNTRY CLUB formed in 1889, boasts of one of the first golf courses in America. The course was originally built by MR. GRIER HERSH and was taken over by the York Country Club in 1899, which had organized with MR. HERSH as its first President. Under the guidance of MR. HERSH, and under the direction of other prominent and public spirited citizens of York, Pa. the organization

reached a point where the old club house and the 9-hole golf course were inadequate for the large roll of members, and in 1920, under the Presidency of MR. S. FERRY LAUCKS, a search for a new golf site was begun. ❖ At a meeting at the York Country Club, May 11th, 1925, the following motion was presented and adopted: ❖ "That a Committee of seven be chosen to organize a real estate corporation, with such a name as they may select, for the purpose of acquiring a site for a new Country Club and building a club house and golf course, and that this Committee will act as the first Board of Directors of the corporation, and are hereby authorized to purchase, in behalf of the proposed organization, such land as they may deem suitable for the purpose, and to proceed with the laying out of a golf course on the land purchased." ❖ The motion was amended to include the appointment of the former golf site Committee, who thus became the first Board of Directors, and were as follows:

The Committee, after viewing a number of sites, were attracted by a plateau two miles South of York and about three hundred feet above the City. The Eastern end of this plateau overlooks the City of York and the far distant Conewago hills, while the Western end terminates in a precipitous crag of rocks known as the "Crows' Nest," an old and well known point of view overlooking the Forks of the Codorus Creek and a large range of wooded hills and many miles of rolling farm land. Here seemed to be a suitable site for the club building. Additional property was secured to the South of this plateau, of sufficient acreage to establish a modern golf course of eighteen holes. The property now contains about two hundred and forty-one acres, eighty of which is standing timber in oak and pine, interspersed with dogwood

and laurel. Across it runs a ravine with a clear running stream of spring water. The club house is located on the Western end at or near the Crows' Nest and is reached by a road constructed through the woodland about half a mile long, leaving the rest of the property free for a golf course. ❖ DONALD J. ROSS and his associates, the very best known golf architects of America, were secured to build this golf course. Here they have constructed an eighteen hole course 6550 playing yards par 72, of the most modern, up-to-date style, and a thorough championship course, yet so arranged that the older players, by using the front of the tees, can eliminate five hundred yards of play. When one finishes a round of golf on the Country Club of York course he enters the club house with a feeling that he has spent not only an afternoon of fine golf, but that he has been entirely lost in the fields and woods, far from the noise and hum of city life—a true day in the country. ❖ The Committee, in fulfilling its

duty, began the erection of the club house. It employed as its architects FRED. G. DEMPWOLF, ROBERT A. STAIR and EDWARD LEBER all of York Pennsylvania, to act jointly in designing the new building. Here has been erected a most modern and up-to-date club house, with a beautiful ball room for social entertainments, together with all necessary card rooms and dining rooms for the enjoyment of the members. Ample locker room and shower baths have been provided for both men and women. One of the charms of this club is the terrace from which one overlooks the golf course and the wonderful stretch of scenic grandeur to the South. This terrace is one hundred and fifty feet long and thirty feet wide and is, beyond question, the most unique of its kind in the country. From this terrace are also seen the tennis courts of the most modern type of construction. ❖ In the winter time, also, there is a trap shooting outfit for the use of the members, and ample place for coasting, tobogganing and other winter sports. ❖ In order to

accomplish this, financially, on August 28th, 1925, there was granted to the Committee a charter for this new club, called The Country Club of York, Pennsylvania, and the old charter of the York Country Club was surrendered. All the legal matters connected with the searching of titles and the taking out of the new charter, and all other legal advice, were given gratuitously by VINCENT K. KEESEY, Esq. ❖ The original Committee automatically became the directors of this new corporation and organized by the election of C. ELMER SMITH, *President*, GRIER HERSH, *Vice-President*, and JAMES S. T. STRAYER, *Secretary and Treasurer*. The financial structure consists of \$125,000.00 first mortgage, and an issue of 40 year income bonds to the amount of \$200,000.00, which have no guarantee as to interest payments, \$40,000.00 of which were subscribed for initiation fees and \$160,000.00 as practically a free gift to the Club, and it was only through the generosity of the members subscribing for these Income Bonds that it was

possible to build this Country Club of York. ❖ In September of 1927, the golf course was opened for thirty days to permit the members to try out the new course. In May, 1928, the golf course was opened and, while the new club house was not entirely completed, the members used the locker rooms, and finally, on Saturday, September 22nd, 1928, the club house, fully equipped, was opened for the use of the members, so that the actual building of the golf course and club house took, approximately, two years. ❖ From the beginning, of the construction of the golf course and club house, the *President*, C. ELMER SMITH, had the hearty support and assistance of the Committee, therefore the Committee feels proud that, under the general authority given to it in May, 1925, it has completed its work faithfully, and the expressions of pleasure and pride in the golf course and club house are ample reward for their labors.



THE CHARTER

BE IT KNOWN
that the subscribers, citizens of the Commonwealth of Pennsylvania, having associated themselves together for the purpose of organizing and maintaining a club for social enjoyments, and being desirous of becoming incorporated, agreeably to the provisions of the Act of the General Assembly of the Commonwealth of Pennsylvania, entitled "An Act to provide for the incorporation and regulation of certain Corporations," approved the 29th day of April, 1874, and the supplements thereto, do hereby declare,

set forth and certify that the following are the purposes, objects and conditions for and upon which they desire to be incorporated:

First: The name of the corporation shall be "Country Club of York, Pennsylvania."

Second: The purpose for which the corporation is formed is the maintenance of a club for social enjoyments and the furtherance thereof by the acquisition, furnishing and maintaining of a club house and of club grounds affording facilities for the enjoyment of golf, tennis and other healthful sports and athletic exercises.

Third: The place where the business of the corporation is to be transacted is in Spring Garden Township, York County, Pennsylvania.

Fourth: The corporation is to exist perpetually.

Fifth: The names and residences of the subscribers are as follows: C. ELMER SMITH and GRIER HERSH, of Spring Garden Township, York County, Pennsylvania and CHARLES H. BEAR, JR.

Sixth: The number of Directors shall be seven, and the names and residences of those who are chosen for the first year are as follows: C. ELMER SMITH and GRIER HERSH, of Spring Garden Township, York County, Pennsylvania, and CHARLES H. BEAR, JR., CARLTON L. HOFF, EARL G. KEGLER, ALEXANDER E. McCLEAN, and JOHN S. McCoy, of the City of York, Pennsylvania.

Seventh: The corporation has no capital stock. Admission to membership and the requirements thereof shall be as prescribed by the By-Laws.

to be very lawful and not injurious to the community.

It is, therefore, ordered and decreed that the charter of Country Club of York, Pennsylvania be and the same is hereby approved, and that upon the recording of the said charter and this order, the subscribers thereto and their associates and successors shall be a corporation for the purposes, upon the terms and under the name therein stated.

BY-LAWS

Article I

BOARD OF DIRECTORS

SECTION 1 / The government of the Club shall be vested in a Board of Directors of ten members, who shall be elected as hereinafter provided. They shall have power to make rules and regulations and alter the same at their discretion; to elect members of the Club; to appoint committees and prescribe their powers and duties; to remit penalties; to make leases

and other contracts; and to do such other acts and things as they may deem necessary for the welfare and purposes of the Club.

SECTION 2 √ The Directors shall be elected at the annual meeting by ballot. The candidates receiving the highest number of votes shall be declared elected and shall hold office until their successors are chosen and qualified.

SECTION 3 √ At the first election after the adoption of these By-Laws, three Directors shall be chosen for terms of one year, three for terms of two years, and four for terms of three years. At all ensuing elections the number of Directors necessary to take the place of those whose terms of office shall then expire, shall be chosen for terms of three years.

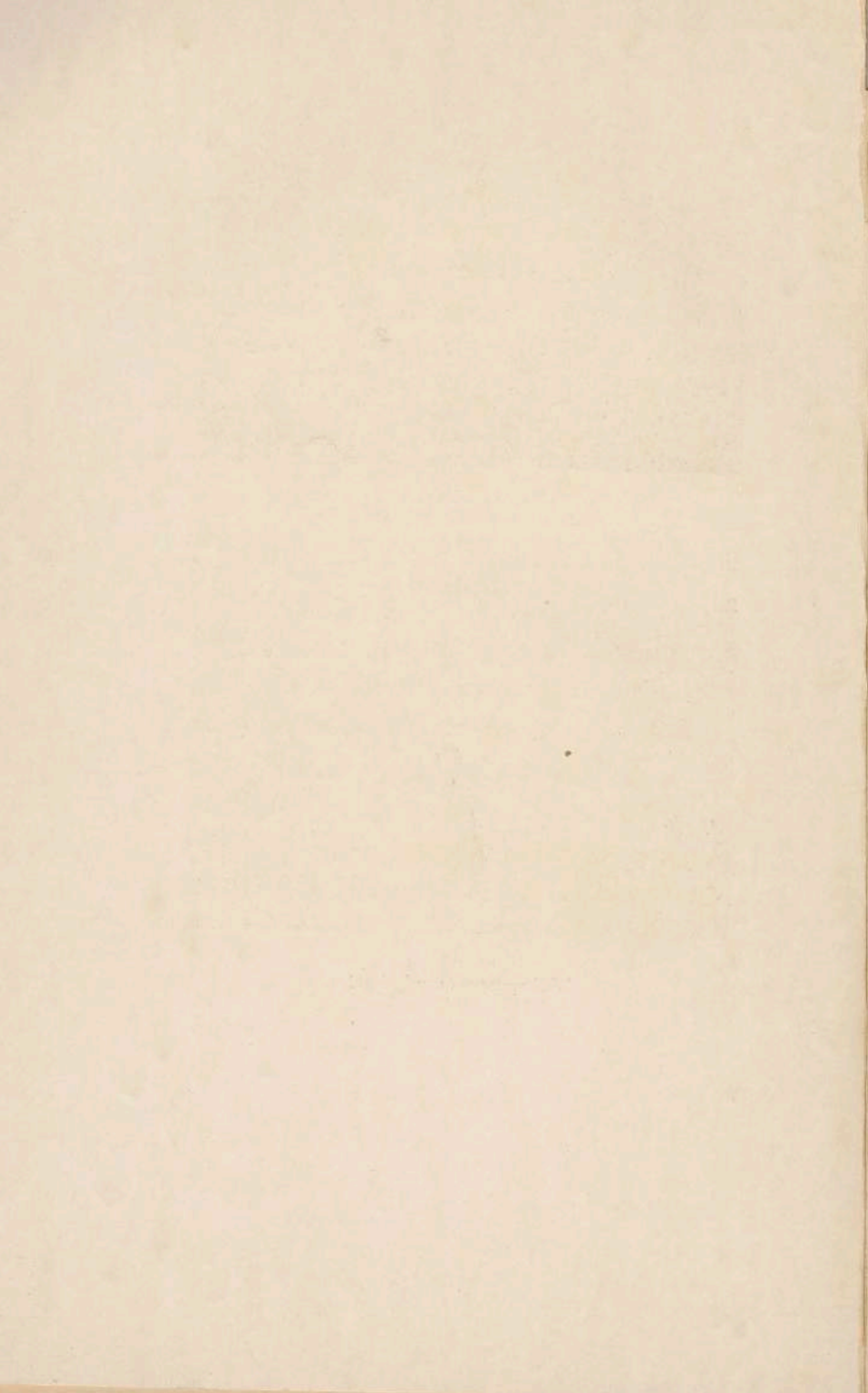
SECTION 4 √ In case of a vacancy in the Board of Directors, the Board shall elect a member to fill the vacancy until the next annual meeting when the Club shall elect a member for the unexpired term.

Article II

OFFICERS

SECTION 1 ∙ The officers of the Club shall be a President, a Vice-President, a Secretary and a Treasurer. The President and Vice-President shall be members of the Board of Directors. The officers shall be elected annually by the Board at its first regular meeting after the annual meeting of the Club and shall serve for the current year and until their successors are elected. In case of a vacancy in any office, the Board shall choose a successor for the unexpired term.

SECTION 2 ∙ The President shall preside at the meetings of the Club and Board of Directors. He shall, with the Secretary, sign all contracts of the Club, and shall perform such other duties as the Club or Board of Directors may assign to him. He shall name annually, subject to the approval of the Board of Directors, the following Committees:

House Committee of 3
Grounds Committee of 3
Golf Committee of 5
Tennis Committee of 5
Entertainment Committee of 9
Ladies Auxiliary Golf Committee of 3
Bridge Tournament Committee of 9
Membership Committee of 6
Winter Sports Committee of 3
Bond Holders Committee of 5

He shall be a member ex-officio of all standing committees. During the absence or inability of the President, the Vice-President shall perform his duties.

SECTION 3 · The Secretary shall keep the minutes of all the meetings of the Club and of the Board of Directors, issue notice of all meetings of the Club and Board of Directors, and conduct the Club's correspondence. He shall, with the President, sign all contracts of the Club and attach the corporate seal thereto when necessary and attest the same. He shall collect all admission fees, dues, and moneys payable to the Club and pay same to the Treasurer. He shall keep the accounts between the Club and

its members, and shall report thereon at each regular meeting of the Board of Directors. He shall notify members elected of their election, and shall perform such other duties as may be required of him by the Board. For his services he shall receive a salary to be fixed by the Board.

SECTION 4 • The Treasurer shall receive from the Secretary all moneys collected for the use of the Club and disburse the same under the direction of the Board of Directors. He shall give bond in such sum and with such security as may be approved by the Board of Directors.

SECTION 5 • At the option of the board the office of Secretary and Treasurer may be held by one person.

Article III

MEMBERSHIP

SECTION 1 • A candidate for membership shall be proposed in writing by one member of the Club and seconded by another; but no candi-

date shall be proposed or seconded by a member of the Board of Directors. When the name of a candidate for membership is proposed, the name of the candidate, together with the names of his proposer and seconder, shall be posted on the bulletin board for a period of not less than two weeks. After the expiration of two weeks, the Board of Directors may elect the candidate a member of the Club.

SECTION 2 ∙ The election of new members shall be by secret ballot. A Majority of the votes cast shall be necessary to elect and two or more adverse votes shall reject a candidate.

SECTION 3 ∙ All resignations must be presented in writing to the Secretary.

Article IV

FEES AND DUES

SECTION 1 ∙ The entrance fees, to Jan. 1st, 1928, to be paid upon admission to the Club, and the annual dues, shall be as follows:

The Board of Directors shall have the right to increase the Entrance Fees, from time to time as in their judgment seems desirable, such increase to be based on the enhanced value of the Club's properties as well as its capacity for memberships.

SECTION 2 • Family Membership shall include parents, sons under twenty-one years of age, all student sons and all unmarried daughters. On the death of parent holding the membership, it shall pass to the surviving parent without the payment of any additional entrance fee.

A widower and one unmarried daughter may be admitted to membership upon payment of the entrance fees and dues as are payable by man and wife.

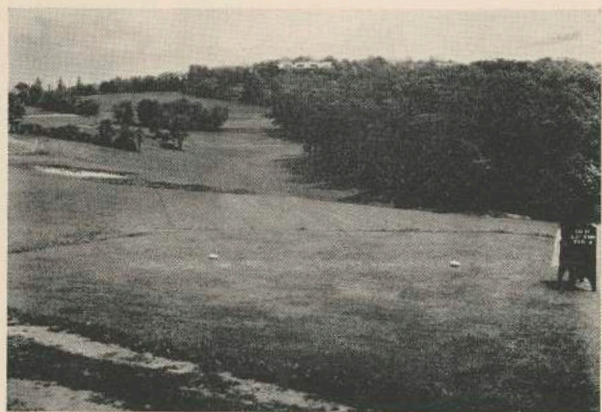
Members' children under sixteen years of age may use the club grounds without charge under such regulations and restrictions as may be imposed by the Board of Directors.

SECTION 3 / The dues of transient members shall be twice the amount paid by resident members of the same class, payable six months in advance. Transient members shall pay no entrance fee. Transient members may become resident members by adding to the excess dues paid a sum sufficient to equal the entrance fee paid by a resident member.

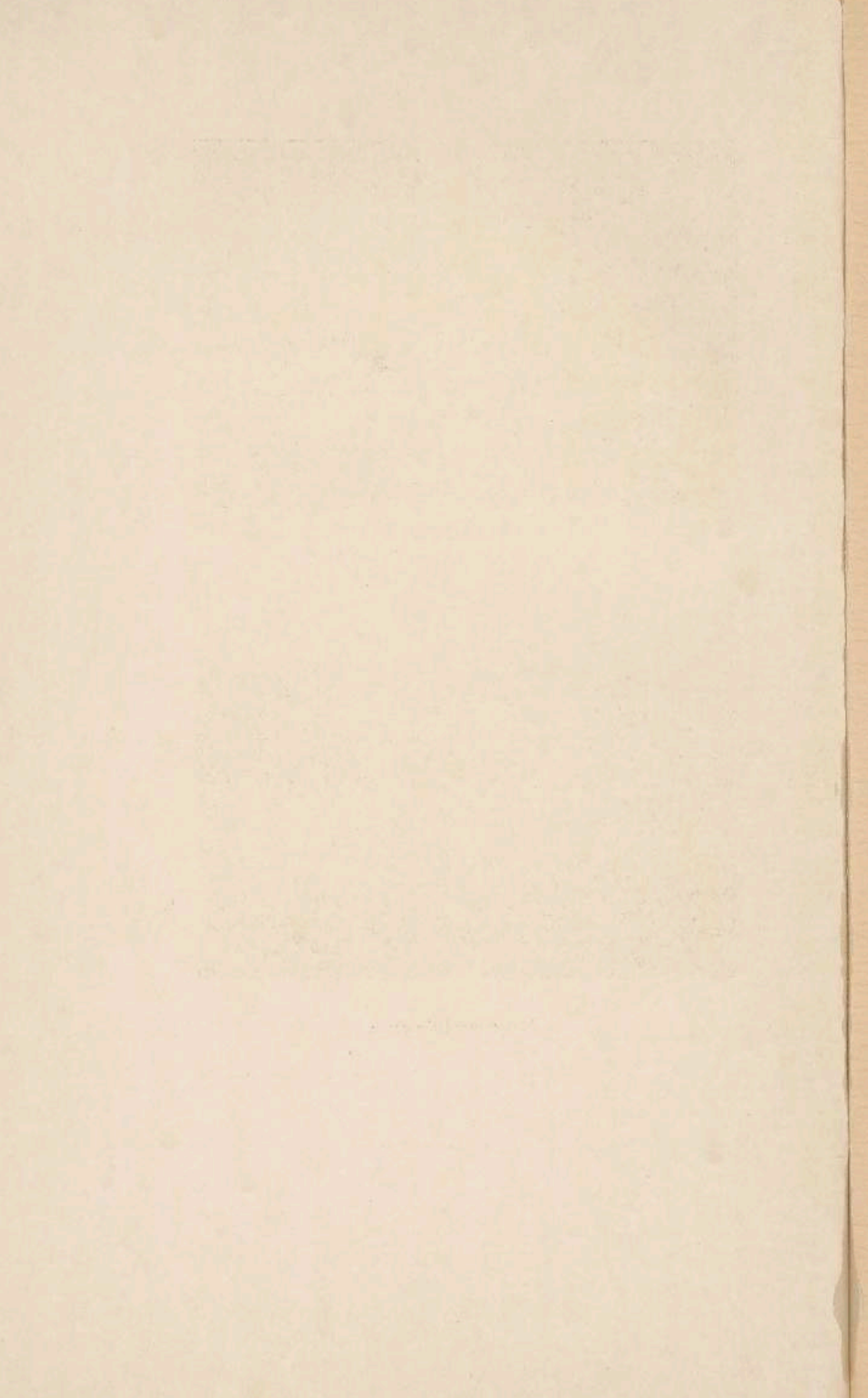
SECTION 4 / All members who shall, before Jan. 1st, 1928, subscribe and pay for Income Bonds of the Club in addition to such bonds as may have been heretofore subscribed for by them, shall be relieved from the payment of

SECTION 5 ∙ When the dues of any member remain unpaid for a period of three months, the Secretary shall notify him that unless the same be paid within thirty days thereafter, his name will be posted as a delinquent, and unless paid within thirty days after such posting his membership shall cease and he shall forfeit all his interest in the property of the Club. The Board of Directors shall have power to remit such penalty.

SECTION 6 ∙ The only members entitled to vote, to hold office or to have an interest in the property of the Club, shall be those who have paid an entrance fee of at least \$200.00.

Article V

DISCIPLINE

SECTION 1 ∙ The Board of Directors shall have power to suspend or expel a member for infraction of any of the By-Laws or Regulations of the Club, or for any conduct which may tender to endanger the good order, welfare or reputa-

tion of the Club, subject to the members' right within ten days to appear to and be heard before a special meeting of the Club, at which meeting a majority of the active members present may sustain, modify or rescind the action of the Board of Directors.

SECTION 2 ∙ For misconduct or neglect of duty, any member of the Board of Directors may be removed from office, by a majority vote of all the active members of the Club, at a special meeting for that purpose.

Article VI

CLUB MEETINGS

SECTION 1 ∙ (As amended.) There shall be an annual meeting of the Club on the first Friday after the first Sunday of January at such hour as the Board of Directors may appoint. Five days notice, by mail, shall be given to all active members.

SECTION 2 ∙ The President may call a special meeting of the Club by giving five days notice by mail to all active members. He shall imme-

diately call a special meeting of the Club by giving like notice at the written request of ten active members who, in their request, shall state the business to be laid before such a meeting. The notice of every special meeting shall state the object or objects for which it is called, and no other business shall come before the meeting.

SECTION 3 · Fifteen active members shall constitute a quorum at all Club meetings.

Article VII

AMENDMENTS

SECTION 1 · Amendments to these By-Laws may be made at any annual or at any special meeting called for the purpose by two-thirds vote of the active members present. Notice of proposed amendments shall be furnished to the Secretary and by him be posted in a conspicuous place in the club house at least twenty days before the meeting at which it is proposed to consider them.

HOUSE COMMITTEE

The duties of the House Committee shall consist of looking after the running of the club-house in all particulars. They shall have charge of the preparation and serving of food and refreshments, the employing of all help, the looking after the locker rooms, and the general upkeep of the club-house. They shall make recommendation to the Board of Directors from time to time as to the charges for use of the club-house or any portion thereof, the prices to be charged for meals, food and beverages and for repairs and modifications to the Club property.

GROUNDS COMMITTEE

The Grounds Committee shall have entire charge of the Club grounds, including that adjacent to the club-house. They shall employ a greens keeper and all necessary labor for the maintenance and upkeep of the tennis courts, and to the roads on the Club property. They shall be responsible for the preservation of the

landscape and the beautifying of the Club grounds. All matters involving changes on the golf course, roads and Club property shall be first referred to the Board of Directors.

GOLF COMMITTEE

The Golf Committee shall have control of all matters pertaining to golf. They shall employ a professor instructor, a caddy master and such help as may be required from time to time. They shall clearly define the duties of those under them. They shall work in close touch with the Board of Directors, keeping the Board advised from time to time on matters, as the game of golf has much to do with the success or failure of the Club operations.

TENNIS COMMITTEE

The Tennis Committee will have charge of all matters relating to the playing of tennis. They shall arrange for the disposition of the courts, the playing of matches and all activities in connection therewith. The upkeep of the courts will be in charge of the greens keeper,

under the direction of the Grounds Committee. The Tennis Committee shall make monthly reports to the Board of Directors.

ENTERTAINMENT COMMITTEE

The Entertainment Committee will have in charge all matters pertaining to the social life of the Club. They shall arrange for the dances, provide the music, and, in conjunction with the House Committee, see that the Club members are provided with entertainment within the limits of the Club. The Board of Directors will cooperate and shall take such action from time to time on all matters that the Committee may bring to its attention.

WINTER SPORTS COMMITTEE

The Club property lends itself to outside winter sports, and it is hoped this Committee can create activities along this line. The Committee shall have entire charge of the sports and shall report to the Board of Directors from time to time as to its progress.

INCOME BOND HOLDERS COMMITTEE

Under the agreement with the Trustee of the first mortgage, Article VII, Section I, a committee of five members of the Club shall be elected from the holders of income bonds. Every holder of \$50.00 par value of bonds shall have one vote, either in person or by proxy.

Each member of the five so elected shall hold office until their vacancies, by resignation or otherwise, are filled by the bond holders as hereinbefore provided.

The Income Bond Holders Committee shall act in conjunction with the Trustee, and no part of the Club's property or its physical assets shall be disposed of without the written consent or direction of a majority of the Committee.

MEMBERSHIP COMMITTEE

The Membership Committee shall receive all applications for membership and after their approval shall post the applications for two weeks following which the Board of Directors shall act.



HOUSE RULES

1. The club house will be opened at 8:30 A.M. and closed at 12:00 midnight. The dining room will be opened for regular meals at 12:00 noon and closed at 8:30 P.M. Except on Sundays and holidays, orders for luncheon must be placed before 2:00 P.M. and orders for dinner before 8:00 P.M. Sandwiches, soft drinks, etc. can be obtained until 11:00 P.M. This rule does not apply to special occasions for which special arrangements should be made in advance with the Steward.

Members are requested to give as much notice as possible in ordering meals, and are required to give at least forty-eight hours' notice in advance of special parties. Any member having ordered a special luncheon or dinner and later wishing to countermand the order shall give the steward twenty-four hours' notice, or the amount of such order will be charged to his account.

2. The employees of the club are not allowed to accept cash for purchases made by members. In every case purchases must be signed for and will be charged to members' account. Guests of a member, who desire to pay cash may do so, but they will also be required to sign their name and name of member introducing them on a "cash" check provided for that purpose.

3. Any member, who is dissatisfied with the service or with charges made to his account, is requested to take the matter up with the House Committee and not with club employees.

To insure the matter coming to the attention of the House Committee write the word "protest" across the face of the check.

4. Members are requested not to give tips or gratuities of any kind to any employee. Employees accepting fees will be subject to immediate discharge and members violating this rule will be reported to the Board of Governors.

A fund will be raised yearly, at Christmas time, for presentation to the employees, and all members will then be given an opportunity to subscribe to this fund.

5. A non-member, who is eligible to any class of resident membership, may not be a guest of the club oftener than once in six months for either golf, tennis, club entertainments, club dances or private dinner parties immediately preceding club entertainments or club dances. Under any other circumstances eligible non-members may be invited as guests at any time, providing they are accompanied by a member.

Members are required to enter on the club register the name and address of their guests, together with their own name and date, as entertaining member.

6. A non-resident guest may be granted the privileges of the club for two weeks, providing the member introducing him secures a guest card properly signed by the Secretary.

7. There will be a cover charge of twenty-five cents for all meals served to non-members.

8. Members will be charged with all damage or breakage caused by themselves or guest introduced by them. They shall also be responsible for debts incurred by their guests.

9. Spiked shoes are not permitted in any portion of the club house except locker rooms, locker-room corridors and men's lounge.

10. Dogs are not allowed in any portion of the club building. They will be allowed on the terraces only when on leash.

11. No advertising matter shall be displayed

anywhere in the club building nor shall any article be offered for sale to members or their guests without permission of the House Committee.

12. Rooms in the club house shall not be rented to anyone except a member, and such member shall not be permitted to grant the privileges of the club to other persons or organizations in conflict with rule number 5.

When the club is rented by a member for an organization such member is responsible for the conduct of the guests and all indebtedness incurred by them.

13. It is understood that members are not to be barred from the club at any time and, therefore, the rental of any of the club rooms does not carry with it the privilege of excluding other members from the club building.

14. The rentals for use of the club rooms for private entertaining are as follows:

Ball Room for one evening for entertainment by a member . . \$ 50.00

Ball Room for one afternoon and evening entertainment by a member.....	65.00
Ball Room for one evening to a member for use by an organization.....	100.00
Ball Room for one afternoon and evening to a member for use by an organization.....	125.00

15. Exceptions or alterations to the above rules may be made at any time either by the House Committee or the Board of Directors.

Resolutions

RESOLVED, That any Club employee who shall at any time serve intoxicating liquor to any member or guest of the Club shall immediately be discharged. And

BE IT FURTHER RESOLVED, That any member of the Club who shall ask or request any employee of the Club to serve intoxicating liquors to any member or guest of the Club shall, after a hearing by the Board of Governors, be, for the first offense, suspended for sixty (60) days, and for second offense his resignation from the Club shall be demanded.

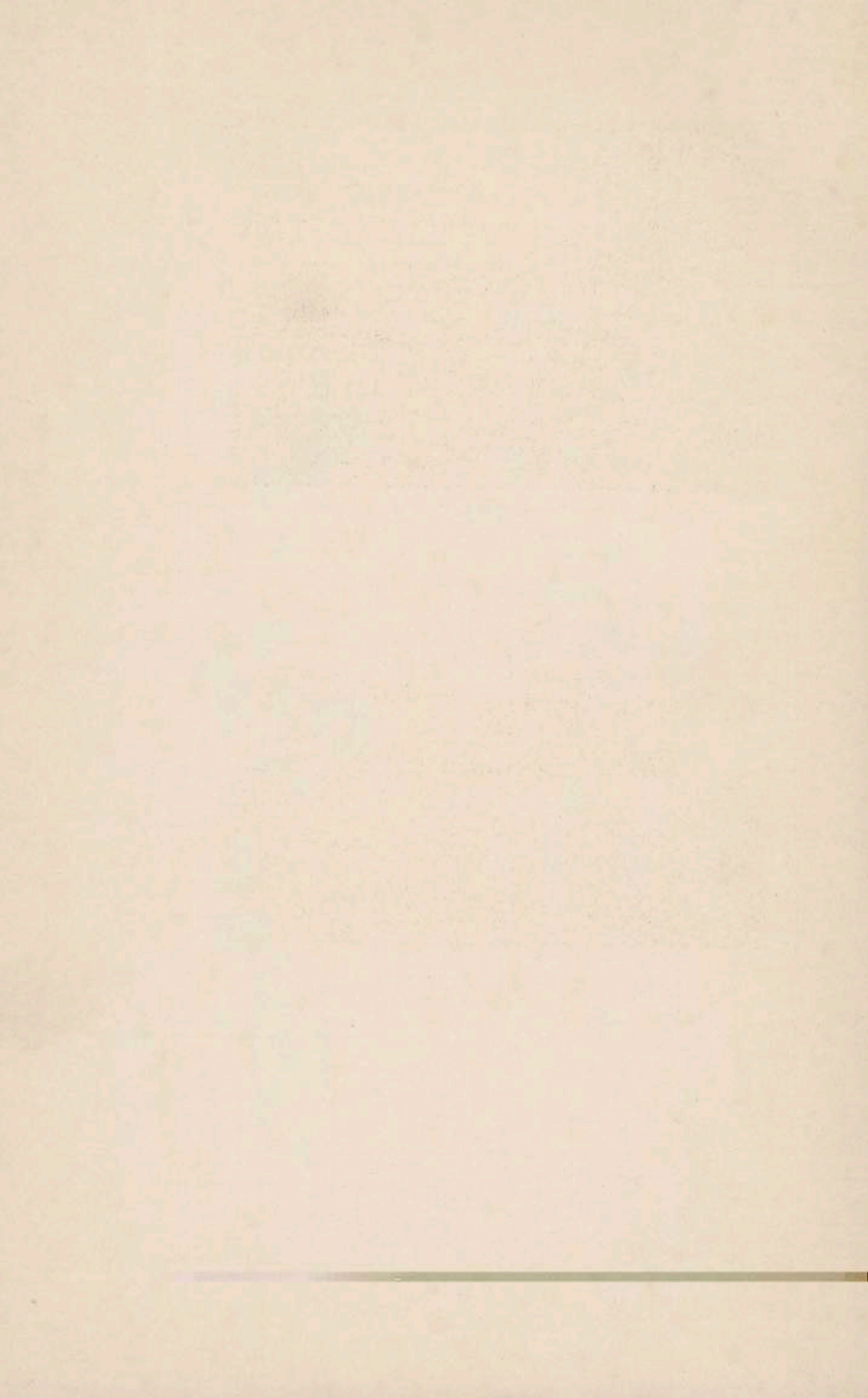
